The Philadelphia Jung Seminar

About the Seminar

The Philadelphia Jung Seminar is an in-depth educational program for those with a serious interest in studying the psychology of C. G. Jung. The content of the seminar is presented by certified Jungian analysts and varies from year to year. In addition to the *Collected Works of C. G. Jung*, seminar topics include the symbolic interpretation of dreams, fairy tales, literature, myths and contemporary culture as well as the clinical applications of Jung's theory and developments in Analytical Psychology since Jung.

The seminar is open to interested candidates from a wide variety of fields and can be the first step towards advanced Jungian analytical training for those in the helping professions. Applicants should be at least thirty years of age with a graduate degree. The seminar format is didactic and interactive, welcoming thoughtful discussion. It is not primarily experiential or process-oriented. Prospective seminar participants are required to be in or have been in Jungian analysis with a certified Jungian analyst for a *minimum* of 20 hours of analysis. An experience of personal analysis insures that each participant will have had an actual experience of Jung's approach to the psyche, so necessary to more deeply understanding his work.

General Information

The Philadelphia Jung Seminar typically meets the second or third weekend of the month on Friday afternoon and Saturday for four months in the fall (Sept. – Dec.) and four months in the spring (Feb. – May). Friday seminar hours are 1:00 – 5:00; Saturday hours are 9:00 – noon and 1:00 – 4:00.

The Philadelphia Jung Seminar will utilize a hybrid format for the academic year 2022-2023, with both video conference as well as in-person attendance, for the September and May seminars. The other months will be video conference only. Requirements for in-person attendance (such as vaccination, testing and masking) will be announced prior to the in-person seminars in accord with CDC and the Commonwealth of Pennsylvania guidelines in effect at that time. The tuition for academic year is \$2,200. Tuition is non-refundable as enrollment in the Seminar is limited.

Admission Process

Please submit the following to the Director of Admissions by June 1 (for admission to the fall semester or by November 1 (for admission to the spring semester).

1. A current resume or curriculum vitae.
2. A three-page essay describing your psychological development, professional history, and reasons for engaging in advanced Jungian study.
3. Have had a minimum of 20 hours of analysis with a certified Jungian analyst. (This analyst is not involved in admission decision-making except to confirm the number of hours of analysis).
4. Notarized Agreement between the Philadelphia Association of Jungian Analysts and Philadelphia Jung Seminar Participants (next page).
5. A \$250 check payable to PAJA for tuition deposit. If accepted into the seminar, this \$250 is *non-refundable* (leaving a balance due of \$1,950). If not accepted into the seminar, the \$250 will be returned.

I realize that (re)admission to the seminar is granted on an annual basis. *Tuition is non-refundable* if you drop out once the semester begins.

I understand that education and training in analytical psychology involves discussion of a variety of topics which may be psychologically stressful or stimulating to some individuals. Seminar topics regularly include discussion of psychopathology, various psychological complexes, childhood and adult trauma or abuse, various forms of archetypal material including archetypal image, myth and fairy tale, dreams and other symbolic material. I understand that should I experience psychological distress it is my responsibility to seek appropriate professional support or treatment.
